

Finance and Loans: DIFASS guarantees transfer

The Mineral & Energy Economy Research Institute (MEERI) of the Polish Academy of Sciences invited the DIFASS projects partners, local and international guests from all over Europe to Krakow to discuss finance and loan guarantee schemes.

The DIFASS project facilitates access to finance for enterprises by exchanging innovative business support measures across Europe. The focus will be on the development and implementation of non-grant based financial support instruments, such as revolving funds, transregional funds and venture capital funds.

Highlights of the Krakow workshop included the ERDF Guarantee Fund, presented by Antonello Chessa of the Autonomous Region of Sardinia (IT), the Regional Seed Financing Forum, presented by Sture Ericsson of Teknikdalen Foundation (SE), BMV Express by Mario Kokowsky of the Center of Technology Western Pomerania (DE), the National Fund for Entrepreneurship & Development by Theodore Theodoropoulos of the Region of Western Macedonia (EL), the Loan Guarantee Scheme by Jackie Walker of WSX Enterprise (UK) and the National Credit Guarantee Fund for SMEs by Andreea Potinteu of the Regional Development Agency Centru (RO).

Participants discussed with the speakers about the pros and cons of their proposals. The objectives of the DIFASS project is to share information and the implementation of the best voted proposals in other regions. The meeting in Krakow proved worthwhile because several agreements were made to implement best practices in other regions. BDF is preparing a regional seed financing forum in Friesland based on the Swedish model.

On day 2 of the meeting the partners were invited to visit the Jagiellonian Center of Innovation in Krakow. This new centre bridges the gap between development of innovation and financing. The center houses numerous start-ups in life science. The market of new medicine is extremely competitive and only few innovations make it to the world market. Some well-known Polish and European pharmaceutical companies work in the Jagiellonian Center and offer opportunities for investment for start-up companies next to coaching and role modelling for young Krakow initiatives.

The next DIFASS meeting will be held in Cagliari and Oristano, Italy on June 19-20. Topic of the meeting is mixed grant & non grant instruments, issues include notification and de-minimis rule.
